### Administration

### • COVID-19 Impacts on School Operations

- Continue to follow direction and recommendation from Alberta Government and Chief Medical Officer of Health (CMOH)
- Amazing resilience demonstrated by staff, students and families
- Layered health measures in schools
- Communicate when there are changes to the operations plans
- Case notifications are going well general information for entire school community
- Rapid testing available to students under 12 when their school goes into Outbreak (10+ cases in 14 days) status
- Handful of classes needing to shift to at-home learning for 10 calendar days as a result of 3 AHS confirmed cases in 5 calendar days

## Administration

- Proof of Immunization / Proof of Negative Rapid Testing
  - Government of Alberta encouraged implementation of policies
  - RVS announced we would be requiring proof of immunization / negative tests just before Thanksgiving with details released on November 3
  - Multiple pathway option for staff/contractors/visitors/volunteers
    - Demonstrate proof of immunization via QR code
    - Show rapid test negative result from within the past 72 hours
  - Requirement does NOT apply to
    - People dropping something off in office/picking something up from office / dropping off children at school / picking up at school
    - RVS students
      - Minister affirmed as of Nov 17<sup>th</sup> "To be clear, there is no legislation in Alberta that requires K-12 students to have specific vaccinations to attend in person schools, nor is Alberta Education considering mandating vaccines of any kind for students in the K-12 education system."
  - Parents entering the school beyond the office (e.g., meet with teacher, attend basketball game, attend indoor school event) – like a restaurant/ hockey rink – show QR code or proof of negative rapid test within past 72 hours
  - Phone, email and video conferencing if people do not want to participate in either pathway

## Administration

- Draft K-6 Curriculum Feedback
  - RVS just completed a series of parent and staff feedback sessions
  - Attendance was light but strong messages received from attendees
  - In process of compiling the feedback and then we will share with government prior to government's January 7<sup>th</sup> deadline
  - We will post that feedback as well on our website
  - Encourage individuals that you can still share your thoughts on the draft K-6 curriculum by completing government's survey <u>https://www.alberta.ca/curriculum-have-your-say.aspx</u> or email the Education Minister <u>education.minister@gov.ab.ca</u>, the Premier <u>premier@gov.ab.ca</u> and/or your MLA
  - Anxiously await to see what government does with the feedback, what revisions are made based on the feedback and implementation next steps

# Alberta School Council Engagement Grant Details

• This grant provides funding to school authorities for each school in order to support school councils fulfilling their legislated responsibilities in the education system and enhancing parent involvement and engagement

### \$500 per each school council

- All funds must be spent in year received, any unused funds must be returned to Alberta Education
- School councils must report annually to the Board on how the grant was handled and used

### **ASCE Grant – Guidelines**

- RVS will provide the funding to each school directly
- Funds must <u>not</u> be directed to registered fundraising societies
- The decisions for the use of the funds must be made by the school councils and recorded in council minutes
- Funds are to be used to support school councils in fulfilling their legislated responsibilities and for parent involvement and engagement activities

### Allowable use of Funds

#### Parent engagement activities and projects

- Workshops for parents to increase capacity for school council members;
- Information sessions on how parents can support student learning at home and at school;
- Parent resources and workshops on important topics such as, mental health and wellbeing, cyber bullying, healthy living, etc.;
- Programs to support multi-cultural and Indigenous families including, English language learners and First Nations, Metis and Inuit learners;
- Parent resources and tools in multiple languages;
- Events to engage parents on important local issues;
- Parent engagement in promoting the value of arts;
- Trainer/facilitator costs for the professional development, workshops or sessions associated with the above.

### Non-Allowable use of Funds

- Entertainment costs, meals, snacks, other food;
- No capital asset purchases;
- Activities that have already taken place;
- Organization memberships or conference fees;
- Fundraising events;
- Prizes or incentives to parents and/or students;
- Payment to school board staff including honoraria, gifts;
- Entertainment activities such as barbeques, volunteer teas, movie nights, dances, concerts or performances, etc.
