Project Description

School Operations Update Related to COVID-19

Date of Meeting: March 10, 2022

Current Status:

Item:

On Feb. 8, 2022, the Government of Alberta announced a plan to remove health measures in the province of Alberta. This plan included three steps with step one with mask usage being optional for all RVS students effective Feb. 14, 2022, when in school or on the school bus. All adults at that time must continue to wear a mask when in RVS facilities.

At the same time, government announced the elimination of their Restriction Exemption Program (REP) effective immediately. RVS lifted our requirement to show proof of immunization or recent negative rapid tests the same day of the announcement about REP elimination. When RVS released Administrative Procedure 173: COVID-19 Hazard Reduction, we committed that this was a temporary measure and that we would review it as the situation evolved. Given the province's recent decision to no longer require proof of immunization / rapid tests to enter other public facilities in the province, we felt it was the time to eliminate this requirement in RVS facilities. In total, the temporary measure was in place for five weeks.

Batch number of two of the government provided masks and rapid tests were made available to families.

The Government of Alberta announced on Feb. 26th that COVID-19-related protocols previously required of schools/school authorities are removed effective March 1, 2022. As previously signalled by RVS, we lifted protocols that are no longer required by government and schools will be begin the journey to return to normal operations starting March 1.

Several health practices continue at this time:

- Use of Alberta Daily Health Checklist and staying home when sick
- Encouraging washing of hands and coughing or sneezing into an elbow or tissue
- Optional use of masks by students, staff, and visitors
- Cleaning of high touch surfaces
- Enhanced ventilation practices in our facilities

We appreciate everyone's patience and understanding as schools and school staff adapt to these new directions from the province and the division. To best meet the needs of their students and school communities, schools will continue to have the ability to consider previous and current operational practices that have worked well. This includes approaches such as staggered lunch and recess times, changes to assemblies, and online options for conferences and meetings.

The Operational Plan related to pandemic operations was significantly edited. The health practices that continue (listed above) are highlighted with a bit of detail, information that field trips outside of Alberta remain paused and information about vaccinations, required isolations, international travel,

grade 12 diploma exams, temporary shifts to at-home learning and information how we support learning for students required to isolated remains. This information can be found at https://www.rockyview.ab.ca/COVID-19.

The acute staffing shortages in January and early February have subsided. We are so very appreciative of our substitute teachers and casual support staff who helped out during that period and other staff who covered for others when no replacement was available.

Staff based out of the Education Centre have all returned to the office.

We continue to appreciate the patience, resilience, and commitment demonstrated by our students, staff, and families during these past 2 years. We know the journey of returning to 'normal' operations will have challenges and potential 'pivots' but we look forward to that important journey.

2022/23 Board Budget Priorities

Background:

The creation of budget priorities is explicitly described within Policy 2 - Role of the Board under the Fiscal Accountability section. Specifically, item 4.1 says the Board shall "approve budget assumptions/principles and establish priorities at the outset of the annual budget process."

After reviewing the budget development process and key assumptions/principles, the Board's Budget Committee discussed budget priorities. The budget committee collected individual trustee feedback before theming the proposed priorities.

The 2021/22 Board budget priorities were:

Rocky View Schools' (RVS) annual budget is driven by the goals and strategies of its Four-Year Plan to foster innovators in their learning journey and the operational needs of the jurisdiction while addressing the pandemic. Recognizing that the superintendent will demonstrate fiscal responsibility by continuing to pursue efficient and effective services while building on innovations over this past year, the Board of Trustees has identified the following key priorities to guide the 2021/22 budget process:

- Pandemic recovery and growth opportunities;
- Student success through targeted funding to classrooms whether face-to-face or online;
- School based supports for students with complex needs;
- Mental health and wellness supports; and
- Literacy and numeracy skill development.


