# BOARD SHOWCASE: HERONS CROSSING & FIRESIDE SCHOOL READ-A-THON CHALLENGE

#### **Project Description**

Students in Kindergarten to Grade 8 at Herons Crossing School in Airdrie and Fireside School in Cochrane recently completed a month-long contest of reading and fundraising. Already a tradition at many Airdrie schools, Fireside adopted a read-a-thon model similar to Herons Crossing at the suggestion of Chantal Chapin, who is a teacher at Herons Crossing and a parent of a Fireside student.

Both schools tallied the number of minutes students spent reading either at home and at school between Jan. 27 and Feb. 27. Students could also log the time they were read to or spent listening to audiobooks. This put everyone on an equal footing, regardless of age or reading ability. Several incentives and prizes were offered to students, and two trustees – Board Chair and Ward 6 Trustee Fiona Gilbert (Cochrane) and Ward 3 Trustee Fred Burley (Airdrie) – championed Fireside and Herons Crossing, respectively. As the trustee of the school that raised the second most amount of money, Trustee Burley will wear Fireside colours during the meeting.

The Read-a-thon Challenge promotes several outcomes of RVS' Four-Year Plan. It encourages students to demonstrate ownership of their learning and engage in real-world learning opportunities that matter to them. With a focus on promoting literacy, it helps students acquire core competencies and meet learning outcomes. The fundraising component also helps students make a positive difference in their school and community.
