## **EXEMPLARY PRACTICE: COCHRANE CHRISTIAN ACADEMY (CCA) READS**

**Teacher:** Josine van den Berg

Student Presenters: Andie Francis (Grade 1), Justin Kulich (Grade 8), Jadon Lee (Grade 5)

#### **Project Description**

In the fall, Cochrane Christian Academy launched its first school-wide home reading program, CCA Reads, which encourages and incentivizes students to read at home. Students track how many nights they read at home and receive a prize every time they attain 25 nights. The aim of CCA reads is to get students reading outside the classroom and to help them develop a love of reading by choosing books they are interested in, rather than books they are assigned.

Since the start of the program, CCA has seen a significant increase in students reading at home, with 75 per cent reading consistently beyond the classroom. In this presentation, literacy lead teacher Josine van den Berg will provide an overview of the program and CCA students from a variety of grades will share the impact it has had on them. This program aligns with Goal 1 of RVS' Education Plan – Advancing student's numeracy and literacy skills.

## NEW SCHOOL IN LANGDON STUDENT ACCOMMODATION ADJUSTMENTS #1308-2023 MOTION BY TRUSTEE SHELLEY KINLEY:

The Board adjust grade configurations and attendance areas effective the fall of 2024 as per consultation Option B without redesignation of two rural areas:

- Sarah Thompson School remain as K-5 with the same attendance area.
- Langdon School change to be a K-8 school with the same attendance area.
- Indus School change to be a K-8 school with the same attendance area.
- New school in Langdon starts in the fall of 2024 as a Grade 9 to 11 school with it becoming a Grade 9 to 12 school effective fall of 2025. The attendance area is the combined attendance areas of Indus School and Langdon School.

Chair/Treasurer Initials

- Current Grade 11 students who live in the new school's attendance area remain designated to Chestermere High School for the 2024/25 school year (as Grade 12 students) with RVS transportation available for this year only.
- Current Grade 10 students who live in the new school's attendance area and currently attend Chestermere High School would need to apply as an out of area student in order to attend Chestermere High School for the 2024/25 school year (as Grade 11 students) with no RVS transportation guaranteed.
