Project Description

Last school year, Grade 1 and 2 French Immersion students at A.E. Bowers Elementary School took part in a collaborative project with Parks Canada to develop a device that encourages visitors to keep parks and picnic areas clean by picking up after themselves.

During a comprehensive three-month learning journey, the students worked with Grade 9 students from George McDougall High School to design and 3D print a garbage receptacle that can attach to picnic tables. The students also produced a bilingual music video for Parks Canada about the importance of keeping the parks clean. They also took an educational trip to Banff, where they got to use the device they made. This project garnered some media attention, with <u>Discover Airdrie</u> writing two stories about the students' work.

During this project, students displayed a number of Alberta student competencies, including critical thinking, communication, problem solving, collaboration, creativity, innovation and citizenship. Achieving these competencies is key to building future-ready students, which is one of the goals of RVS' Education Plan.

Background:

Alberta Inclusive Education Policy: Alberta's education system is built on a values-based approach to accepting responsibility for all children and students. Inclusion is a way of thinking and acting that demonstrates universal acceptance of, and belonging for, all children and students.

Alberta Education: Inclusion is not just about learners with special needs. It is an attitude and approach that embraces diversity, and learner differences and promotes equal opportunities for all learners in Alberta. Alberta's education system is built on a values-based approach to accepting responsibility for all children and students. Every learner has unique needs. Some learners have profound and ongoing needs and others have short-term or situation-based needs. This calls for flexible and responsive learning environments that can adapt to the changing needs of learners. When teachers use evidence-based instructional practices and strategies, woven through multi-tiered systems of supports, to nurture student academic and social-emotional engagement, it can lead to greater academic achievement and success for all children and students.

Background:

The Rocky View Schools calendar development process is meant to provide a consistent and practical process to build annual operating calendars that both supports the vision and direction of the Division in the provision of high-quality learning for students and honours the greater community by providing opportunities for feedback. The RVS calendar has enabled the structures that are necessary to support continuous professional learning to exist while addressing all provincial regulatory requirements.

Current Status:

The Calendar Development Committee includes central administration along with teachers and administrators appointed by the ATA Local #35. The committee meets and creates initial calendar drafts which are provided to the Board of Trustees. If general support exists, then they are distributed to Rocky View Schools' community for feedback. An online calendar feedback survey was developed by the RVS Communications Dept. and made available to the RVS community for their feedback. Survey opened on May 21, 2024 and closed on June 17, 2024. For complete results please see attached Calendar Feedback Summary.





(Feedback was similar for all four questions and mirrored much of what was heard in the calendar option-specific questions.)

- Nov. week-long break:
 - Doesn't really allow staff to go away a possible negative for staff wellness
 - Could be disruptive for students who need continuity of learning
 - Means hourly-paid school staff would lose a week's pay some suspicion this is a costsaving move
 - Break would be better if tied to thanksgiving
 - Financial burden on parents who cannot afford to go on vacation and will need to find childcare for that week - and these students won't get a break as they'll still be in a structured program
 - Teacher and staff wellness would be better served by looking at issues like classroom complexity and class sizes than adding an additional week-long break in November.
 - O Non-inclusive as only higher income families will like and can afford this extra break
 - Suggestion to have winter break start earlier in December rather than introducing a November break
 - Too close to winter break
 - Would prefer to have time off in summer than in November trading off days in June for November is unpopular
 - Long weekend in November preferable to full week off
 - Make spring break two weeks long instead
- Maximizing length of summer vacation a priority
- School should not start until after Labour Day
- Starting school before Labour Day:
 - Many students are still away and teachers have to repeat themselves on the following Tuesday
 - Many comments saying they would keep their kids out if school started before Labour Day
- There should be more days in school for students, not less. Too many breaks already.
- Days at the end of the year for Kindergarten not needed would prefer days throughout the year to hold parent/teacher meetings and plan
- Mid-week PL days are hard on working parents
- Limit change to the calendars given all the other change going on for students and staff ie. BASS
- January mid-week organizational day is only needed at high school level
- Lack of understanding of what PL and organizational days are for calls to cut the number or eliminate them entirely
- Early release Fridays are inconvenient for working families
- Calendar options do not include non-Christian holidays. With rising diversity, how is RVS going to accommodate this?
- Would like more of an explanation for why the number of school days per option is different
- Quite a few comments thanking RVS for giving community members the opportunity to provide feedback
- Requests to stop staggered entry.

Item: Chestermere Student Accommodation Engagement

Date of Meeting: October 3, 2024

Background:

Student spaces in Chestermere have not kept up with the community's rapid growth. With a 262 per cent rise in population over the past two decades, RVS' schools in Chestermere are experiencing enrollment pressures that require new school builds as soon as possible.

With one school funded for design in the 2024 provincial budget, it will be several years before the community sees any relief. While timelines remain uncertain for the building of the announced Kindergarten – Grade 9 school, it is expected to be a minimum of four years before these new student spaces bring relief to the community's overfull schools.

Chestermere schools may find temporary relief by altering student space distribution and boundaries. This follows 2023/24's Balancing Airdrie Student Spaces accommodation engagement and decision.

An RVS working group conducted a thorough review of Chestermere's situation in 2023/24, identifying possible solutions to address the student accommodation challenges including reviewing attendance areas, grade configurations, alternative schedules and modular classrooms.

The working group's findings and suggestions, combined with the announcement of design funding for a new school in Dawson's Landing and approval for additional modular classrooms, led to an option for consideration to help better distribute student spaces across Chestermere:

- East Lake School's English program expands from Kindergarten to Grade 6 to Kindergarten to Grade 9 beginning September 2025.
- The Christian and French Immersion programs for Kindergarten to Grade 6 remain at East Lake School while the Christian and French Immersion programs for Grades 7 to 9 would continue to be offered at Chestermere Lake Middle School only.
- Communities of Chelsea, Bridgeport commercial, Waterford, Waterford Estates, and Paradise Meadows are redesignated from attending East Lake School to Rainbow Creek Elementary School.
- North Acreages area is redesignated from attending East Lake School to Prairie Waters Elementary School.
- Clearwater Park community is designated to attend Rainbow Creek.
- Bridgeport North is designated to attend Prairie Waters.

This will have a range of impacts for multiple schools, students, families, and staff.

In alignment with AP 171 – Student Accommodation Consultation, administration is bringing forward a recommendation to the Board on a student accommodation consultation plan and timeline.

Current Status:

RVS Administration has developed a proposed plan to engage the community to gather feedback and insights on student accommodation changes that would best overall serve Chestermere students. The Chestermere Student Accommodation engagement would take place throughout the fall and conclude in December 2024. It consists of both an in-person opportunity where RVS will share information and resources and listen to feedback, as well as an online opportunity where RVS shares information and gathers community feedback.

RVS administration is committed to actively engaging the community and ensuring clear, consistent and open communication throughout the process.

It is recommended a decision be made at the public Board meeting scheduled for Jan. 23, 2025. Any changes made as a result of this decision would come into effect for September 2025.

Item: Enrolment Update

Date of Meeting: October 3, 2024

Background:

Annually, Boards across Alberta submit to the Government of Alberta their student enrolment as of September 30. While enrolments fluctuate daily, these September 30th numbers are important for funding purposes and generally used to describe a school division's student population.

At the end of September 2023 RVS had 28,602 students that we served. This was an increase of 990 from September 2022. By June 2024, RVS had just under 29,000 students attending our schools. These numbers are headcount and is not the full-time equivalent (FTE) which would be lower as Kindergarten students only count as 0.5FTE.

Current Status:

In January 2024, RVS submitted to government our projected enrolment for the 2024/25 school year. Projecting a division's enrolment is a complicated art which looks at community growth, grade to grade growth, historical trends, and census and birth rate data. The projection for the 2024/25 school was 29,350 students. This would be an increase of 748 students from last year (2.6% growth compared to fall 2023). General community population growth is driving the enrolment increases.

As of Friday September 27, 2024, our enrolments were 29,256 students. We have now removed most of the students who have not shown or contacted the school this fall. Final numbers will be determined in the coming days when any duplicates or students funded by means other than Alberta Education (Indigenous Services Canada or international students) are removed from our Alberta Education submission.

Final enrolments will be determined in the coming week and reported on a school-by-school basis on October 17, 2024 to the Board.

Item: Policy 17 Student Transportation

Date of Meeting: October 3, 2024

Background:

Policy 17 Student Transportation provides direction regarding bus service for students across RVS. Government has made some changes to the funding manual and transportation regulation but, due to a variety of factors, many of those changes have not been required to be implemented at this time.

This policy was last reviewed in September 2020 with only *Education Act* references changed. Prior to that, the policy received minor updates during 2016 but has been relatively the same for 10+ years.

Current Status:

As part of the Policy Committee's mandate, they have reviewed the policy and are making a series of proposed adjustments to simplify and modernize the policy, reduce technical details from the policy (which would be picked up in the administrative procedure), and reflect current practice.

The intention of the revised policy is to provide high-level direction for student transportation in RVS that is aligned with government regulation, but also reflective of the local context and the priorities of the Board. While there are lots of edits and deletions throughout the document, it is important to note that the revised policy does not make any changes to current service levels or practices for transportation. Some sections have been removed from the policy and will be placed in the Student Transportation AP as these sections refer to the "how" of student transportation. Some sections have been removed because they no are no longer relevant.

Highlights of edits include:

- Updating the Background section to reflect the overarching vision and approach for student transportation.
- Removed definition section to simplify with an intent that details such as definitions would be moved into administrative procedures.
- Eligible riders section simplified, does not rewrite what is in government regulations and reflects current practice. Removes legacy pieces no longer applicable (e.g., 1995 annexed areas).
- Service levels reflect current practice and will need to be changed when updated government regulations are brought into effect. Attempted to remove differentiation between rural, urban and rural municipal riders.
- Added Kindergarten bus service levels as this is over and above government mandate.
- Maintain the option for running bus service closer to the school than the usual distances for
 younger students when Transportation Department determines it is necessary for safety. This
 removes a statement that was not equally applied about 4 lanes or a provincial highway as
 the current language was deemed to be problematic and not consistently applied.
- Maintained alternate stop option for families with same conditions.

- Clarify that our buses only run within RVS' boundaries and bus only run to their designated school and divisional programs of choice may have a set transportation service area. This is current practice although Committee feels that clarity may need to be provided by the Board about what the transportation service boundary is for each divisional program of choice.
- Added a statement about ride times which is new for the policy. The proposed length (75 minutes) is our current, albeit unwritten service standard. This would provide clarity to all.
- Walk limits are maintained at their current levels but rewritten to simplify. The current policy
 only discusses walk limits for urban riders, but it also talks about distance between stops for
 rural and municipal rural riders.
- Maintains that it is the Board who establishes transportation fees.
- Safety section added given it is such an important piece guiding the operation of our buses.

Proposing that the changes to Policy 17 Student Transportation would not take effect until December 1, 2024, so that time is provided to update the administrative procedure.

BACKGROUND

The Board acknowledges its obligation to provide transportation for resident students in accordance with the *Education Act* and the Student Transportation Regulation. In addition, the Board supports the transportation of other students in accordance with this policy.

The Board believes that the responsibility for providing safe student transportation is shared by employees of the division, school bus contractors and their employees, parents/guardians and students.

The Superintendent is charged with maintaining administrative procedures that are consistent with this policy for the provision of a student transportation system that is managed with high regard for student safety, fiscal accountability, and efficiency.

GUIDELINES

- 1. Eligible Riders
 - 1.1. Those authorized by government regulations;
 - 1.2. Those authorized by the Board of Trustees including but not limited to:
 - 1.2.1. Students attending a kindergarten program;
 - 1.2.2. Students attending a divisional program of choice where transportation has been approved;
 - 1.2.3. Transportation route exceptions;
 - 1.2.4. Transportation Service Agreements with other school divisions;
 - 1.3 Those authorized by the Superintendent or designate.

2. Service Levels

- 2.1. Transportation may be provided for Eligible Riders who:
 - 2.1.1. Reside 1.5 kilometres or more from the school they attend and are in Grade 6 or lower:
 - 2.1.2. Reside 2.0 kilometres or more from the school they attend and are in Grade 7 or higher.
- 2.2. Bus stops serving Eligible Riders for a specific school will be located no closer to the school than 2.0 kilometres, excepting those schools with students in grades 6 or lower for which bus stops serving Eligible Riders will be located no closer to the school than 1.5 kilometres.
- 2.3. Bus service may be extended to students who live closer to their designated school than the eligible distance when safety concerns are identified by Transportation Department.
- 2.4. Bus service will be provided for kindergarten students as follows:
 - 2.4.1. Full Day Program to and from school each school day
 - 2.4.2. Half Day Program one way each school day

- 2.5. Additional transportation between one alternate location (childcare, family members home, etc.) and school may be provided subject to the following:
 - 2.5.1. Alternate location is within the school attendance boundary of the school the student attends;
 - 2.5.2. Space is available on the bus for the required route;
 - 2.5.3. Requested upon registration.
- 2.6. School buses shall travel only within the defined Government of Alberta boundary of Rocky View Schools and within the school's / divisional programs of choice approved for transportation's transportation service boundary.
- 2.7. The ride time from pickup to drop off for riders will typically be less than 75 minutes.
- 2.8. The walk limit for urban students to a bus stop is typically 400m for K to grade 6 students and 1.2 km for grade 7 to grade 12 students. The walk limit for rural students to a bus stop is typically 800m from the end of their driveway.
- 2.9. Service level exceptions may be granted by the Superintendent of designate in consideration of:
 - 2.9.1. Students requiring customized or enhanced school transportation services;
 - 2.9.2. Student safety;
 - 2.9.3. Efficiency.

3. Transportation Fees

- 3.1. The Board will annually review and approve student transportation fees.
- 3.2. A fee waiver and refund process will be in place for transportation fees and details of these processes must be communicated annually to parents/guardians.
- 3.3. Transportation fees must be paid prior to accessing service unless:
 - 3.3.1. A payment agreement is in place; or
 - 3.3.2. A transportation fee waiver has been approved by the Senior Manager of Transportation or designate.

4. Safety


- 4.1. School bus safety is the responsibility of the bus driver, student riders, their parents/guardians and the school.
- 4.2. Parents/guardians have the responsibility for getting their child/children to and from the bus stop and while standing at the stop/waiting for the bus to pickup and/or drop off.
- 4.3. School buses are an extension of the school and as such, students are expected to adhere to school and bus safety and behaviour expectations as well as the RVS Student Code of Conduct.

- with regard for student safety;
- fiscal accountability;
- length of ride and parent satisfaction.

The Board believes that the responsibility for providing safe student transportation within its jurisdiction is shared by employees of the Board, school bus contractors and their employees, parents and students.

The Board recognizes its responsibility to determine:

- who is authorized to be transported;
- conditions under which they may access such services;
- levels of service for the transportation of its authorized passengers.

The Board shall annually review and approve student transportation fees and, if required, submit fee increase for Ministerial approval as per Alberta Education Regulation 102/2017.

Parents have the responsibility for getting their child to and from the bus stop.

The Board acknowledges its obligation to provide transportation for resident students in accordance with the *Education Act* and the Student Transportation Regulations. In addition, the Board supports the transportation of other students in accordance with the guidelines in this policy.

DEFINITIONS

Attendance Boundary for a The School:

The boundary of the area from within which a Resident Student attends a school designated by the Board.

Child: A child is an individual enrolled in a Kindergarten program

and who is younger than six (6) years of age as of

September 1st of any year.

Designated School: The school the Board has directed the student to attend.

Independent Student: As defined in Administrative Procedure AP303.

Resident Student:

• A student whose custodial parent(s) reside(s) within the

boundaries of Rocky View Schools.

• A student in the care of a foster parent under the Child Welfare Act if the foster parent resides within the

boundaries of Rocky View Schools.

 An independent student who resides within the boundaries of Rocky View Schools.

Road(s): A public or subdivision road built to the applicable

municipality's standards that is maintained and serviced by the province, municipality, or private individual or company.

Rural Municipal Passengers:

or the City of Chestermere.

Rural Passengers: Authorized passengers who do not reside in a city, town,

village, or hamlet.

Transportation Assistant: A person who is responsible for assisting and supervising

Transportation Service

Boundary:

GUIDELINES

1. Authorized Passengers

- 1.1 Resident student of Rocky View Schools (RVS) or child whose parent(s) live within the boundaries of RVS enrolled in grades K to 12 who resides 2.4 kilometres or more from the student's designated school.
- 1.2 Resident student of RVS or child whose parent(s) live within the boundaries of RVS enrolled in grades K to 12 who resides less than 2.4 kilometres from the student's designated school, provided that the student's parent(s) has paid the resident student transportation fee set by the Board for the current school year.
- 1.3 Resident student of RVS or child whose parent(s) live within the boundaries of RVS as identified by the Director of Learning Supports as requiring transportation.
- 1.4 Resident student of RVS or child whose parent(s) live within the boundaries of RVS who is attending a RVS school other than their designated school provided the Transportation Department approves the required annual application by the parent(s) for transportation of the student or child. Approval of the application for transportation is subject to all the conditions below:

- 1.4.1 The school bus, after the students designated to that particular bus have been accommodated, has a weighted load less than 85% of the bus manufacturer's capacity. Available seating shall be distributed on a first-come first-serve basis.
- 1.4.2 Access to bus service is from a new or an existing bus stop on an existing bus route providing service to the school at which the student or child is enrolled. The location of the bus stop shall **not increase** the distance traveled by the bus.
- 1.4.3 The resident student transportation fee set by the Board for the current school year has been paid.
- 1.5 Resident student of RVS or child whose parent(s) live within the boundaries of RVS in an area that has been authorized to receive bus service to a specified school other than the designated school. Limited bus service from not more than two predetermined bus stop locations may be provided if the Transportation Department approves the required annual application by the parent(s) for transportation of the student or child. Approval of the application for transportation is subject to all the conditions below:
 - 1.5.1 The area is approved by the Board for the current school year to receive alternate bus service, to enhance a school's educational program based on a recommendation from the Superintendent of Schools, after consideration of the effects on ride times for other students on the route.
 - 1.5.2 The bus stops will potentially provide service for a minimum of ten (10) students from each of the up to two bus stops providing service to the alternate school.
 - 1.5.3 The location of the bus stop shall provide service to potential students within two (2) kilometres of their home and shall not increase the distance traveled by the bus more than ten (10) kilometres per trip (a.m. and p.m. service combined cannot increase travel distance by more than twenty (20) kilometres).
 - 1.5.4 The resident student transportation fee set by the Board for the current school year has been paid.
- 1.6 Non-resident student or child who resides in lands annexed by the City of Calgary in 1989 and 1995 provided the applicable student transportation fee for non-resident students living in the 1989 and 1995 annexed lands set by the Board for the current school year has been paid. Priority will be given to resident students i.e., secondary residence is located within annexed area.
- 1.7 Non-resident student or child residing outside of a school's transportation service boundary who has been admitted to a school operated by the Board provided the Transportation Department approves the required annual application by the parent(s) for transportation of the non-resident student or child. Approval of the application for transportation is subject to all the conditions below:
 - 1.7.1 The school bus, after the students designated to that particular bus have been accommodated, has a weighted load less than 85% of the bus manufacturer's capacity. Available seating shall be distributed on a first-come first-serve basis.

- 1.7.2 Access to bus service is from a new or existing bus stop on an existing bus route providing service to the school at which the non-resident student or Child is enrolled.
- 1.7.3 The non-resident student transportation fee set by the Board for the current school year has been paid.
- 1.8 Resident student or child of another Board to that Board's school or to a school operated by RVS provided a transportation agreement with that Board is in place.
- 1.9 Transportation assistant assigned to authorized passenger(s).
- 1.10 Up to two pre-school children of the bus operator provided:
 - 1.10.1 Appropriate child restraints are installed by the contractor;
 - 1.10.2 Adequate space on the bus is available; and,
 - 1.10.3 The presence of the children does not interfere with the safe operation of the school bus.
- 1.11 A resident student, a non-resident student or Divisional personnel requiring alternate or occasional transportation as approved by the Director of Transportation.

Service Levels

2. Service for Rural Passengers

- 2.1 School buses shall travel only within the Transportation Service Boundary of each school on road(s) that are authorized by the Director of Transportation.
- 2.2 Bus service is provided at the mouth of a cul-de-sac for students whose residence is 0.8 kilometres or less from the road(s) on which the bus has been designated to travel.
 - 2.2.1 On road(s) that a school bus travels, bus stops shall be space at intervals of approximately 0.8 kilometres except if Clause 2.2.2 of this policy applies.
 - 2.2.2 Exceptions to Clause 2.2.1 of this policy may be granted by the Transportation Safety Committee, comprised of RVS Transportation Department and Contractor personnel, which shall review student safety inclusive of safe travel to and from bus stops while maintaining efficiencies.
- 2.3 School buses shall only enter onto private property to pick up students when authorized by the Director of Transportation, provided the private roadway and turnabout are deemed appropriate by the Director of Transportation, for one of the following reasons:
 - 2.3.1 A student as identified by the Director of Learning Supports as requiring specialized or enhanced transportation services;
 - 2.3.2 A student whose residence is in excess of 2.4 kilometres from the road(s); or,
 - 2.3.3 To facilitate routing efficiency.
- 2.4 If authorization of private property pick-up is granted the ongoing requirements of the property owner are:

- 2.4.1 Written permission to enter onto the property, and
- 2.4.2 The driveway or private road(s) is maintained and there is a suitable turn-a-round for a school bus.

3. Service for Urban Passengers

- 3.1 Bus stops serving authorized passengers for a specific school shall be located no closer to the school than 2.0 kilometres, excepting those schools housing elementary students for which bus stops serving authorized passengers shall be located no closer to the school than 1.5 kilometres.
- 3.2 Maximum walk distance to a bus stop is 1.2 kilometres for students enrolled in grades 7 12 and 0.4 kilometres for students enrolled in grades K 6.
- 3.3 Bus service will be provided for K 8 students who are directed to a school outside of their local community when travel to that school requires them to cross a provincial highway or major intersection (four or more traffic and/or turn lanes).

4. Service for Rural Municipal Passengers

- 4.1 Bus service in these municipalities shall be provided if the distance from the furthest residence to the school is in excess of 2.4 kilometres, excepting those schools housing elementary students for which bus service shall be provided if the distance from the furthest residence to the school is in excess of 1.5 kilometres.
- 4.2 Bus stops serving authorized passengers for a specific school shall be located no closer to the school than 2.0 kilometres, excepting those schools housing elementary students for which bus stops serving authorized passengers shall be located no closer to the school than 1.5 kilometres.
- 4.3 Distance between bus stops shall be approximately 0.8 kilometres.

5. Exceptions to the Limits of Services

Exceptions to the limits of service outlined may be made by the Director of Transportation for students identified by the Director of Learning Supports as requiring customized or enhanced and designated school transportation services.

6. Transportation between Day Care or Care Giver or Alternate Location and School

If requested upon registration by the student's parent(s) this service will be provided subject to the following:

- 6.1 Day Care or care giver's or alternate location is within the school attendance area of the student's designated school.
- 6.2 Space availability on the route requested

- 6.3 Service to Day Care or care giver's or alternate location is **in addition** to the service between the student's residence and the designated school. Service from more than two locations **will not** be provided.
- 6.4 Service to be applied for on an **annual** basis.

Item: Advocacy Update

Date of Meeting: October 3, 2024

Background:

The Board's Advocacy Committee is charged with coordinating the advocacy efforts of the Board in its endeavour to positively impact the students we serve. This includes advancing advocacy priorities of the Board and implementing advocacy plans and strategies.

On May 30, 2024, the Board of Trustees approved new Board advocacy priorities that includes two broad priorities each with four sub-priorities:

Space for Students

Municipal and provincial governments must support growing school divisions in bolstering infrastructure where students and staff can thrive.

- New Schools the provincial government must build new schools equal to the pace of increasing student populations.
- School Sites municipalities must prioritize right-sized, shovel-ready sites for new schools in early phases of any development plans.
- Modulars provincial government must fund modulars and relocations as necessary to provide needed classroom space.
- Innovative and Well-maintained Schools provincial government must dedicate sufficient resources to address technology evolution and aging buildings.

Support for Students

Government must invest in the success of every student to ensure all students experience an education that is inclusive, safe and supportive.

- Equitable Funding every student must be fully funded every year.
- Classroom Complexity provincial government must invest significantly to support student success in increasingly complex classrooms.
- Prioritize Public Education provincial government funding for public education must be prioritized and strengthened.
- Mental Health services and resources for mental health and wellbeing must be increased to meet the evolving needs of our students and staff.

Over the summer, RVS' Communication and Engagement department started work on developing an advocacy plan and strategies for the 2024/2025 school year aligned with these new priorities. These were reviewed with the Advocacy Committee in August and approved by the Board Planning Committee in September.

Current Status:

The Advocacy Committee, supported by the Communications and Engagement team, is working hard to implement the Board advocacy plan and is providing an update to the Board on the work to date.

The 2024/2025 Advocacy Plan builds on the successes and learnings of previous plans with high-level goals to:

- Build understanding and support
- Communicate consistently through diverse channels
- Empower participation

Currently, the RVS corporate website is being redeveloped and updated with current Board advocacy priorities and a "one-sheet" has been created that can be downloaded and/or printed that highlights the advocacy priorities. Updated enrolment and funding graphics will be created once enrolment numbers have been officially reported for this current year.

Letters of invitation to meet have been sent to Premier Danielle Smith and Education Minister Demetrios Nicolaides, and the Board hosted both Minister Guthrie and Minister Nicolaides at the groundbreaking ceremony for Bow Valley High School last week in Cochrane. This provided an opportunity to share RVS urgent need for relief from enrolment pressures across the division and speak about the operational pressures being felt as a result of rising operational costs.

With the recent announcement by the province related to the new School Construction Accelerator Program highlighting the requirement to work collaboratively with municipalities, RVS will continue to engage with all municipal partners to ensure needed school sites are fast tracked. The Board is meeting with the recently elected Mayor and Council for the City of Chestermere later in October.

Future Direction

The Advocacy Committee will continue to implement the 2024/2025 advocacy plan to advance the priorities of the Board and take every opportunity presented to share key messages related to RVS' advocacy priorities of Space for Students and Support for Students. This includes a multi layered approach to communicating and sharing information with all our stakeholders and partners throughout the year.

Additionally, the Committee is monitoring emergent advocacy matters as the government shares their plans related to education policy, regulation, funding and other matters that impact RVS.
