EXEMPLARY PRACTICE: ENVIRONMENT CHALLENGE, AE BOWERS

Last school year, Grade 1 and 2 French Immersion students at A.E. Bowers Elementary School took part in a collaborative project with Parks Canada to develop a device that encourages visitors to keep parks and picnic areas clean by picking up after themselves.


During a comprehensive three-month learning journey, the students worked with Grade 9 students from George McDougall High School to design and 3D print a garbage receptacle that can attach to picnic tables. The students also produced a bilingual music video for Parks Canada about the importance of keeping the parks clean. They also took an educational trip to Banff, where they got to use the device they made. The students made an instructional video on how to use the device in both French and English. A QR code was created for the video and affixed to the table for users to scan and know how to use. This project garnered some media attention, with Discover Airdrie writing two stories about the students' work.

During this project, students displayed a number of Alberta student competencies, including critical thinking, communication, problem solving, collaboration, creativity, innovation and citizenship. Achieving these competencies is key to building future-ready students, which is one of the goals of RVS' Education Plan.

Parks Canada further contacted the teachers and advised that this project has been brought forward to the Board and have this implemented throughout Parks Canada. These will have a place in Banff National Park, and updates on the process will be provided to the teachers.
