Item: Chestermere Student Accommodation Decision

Date: January 23, 2025

Background

In October 2024, RVS' administration brought forward a proposal to engage families whose children attend Chestermere schools. The rationale was, because Chestermere's increasing student population and lack of approval of schools resulted in overutilized schools in Chestermere. Student spaces in Chestermere have not kept up with the community's rapid growth. With a 262 percent rise in population over the past two decades, RVS' schools in Chestermere are experiencing enrollment pressures that require new school builds as soon as possible.

Currently, 4 out of 5 schools in Chestermere are operating at full capacity as of September 30th, 2024. The overall utilization of Chestermere schools is at 94%, which is not sustainable for long. The only middle school in Chestermere is currently being utilized at 100%, and due to the land constraints, there cannot be any more modular classroom units added to this school.

With one school site in Dawson's Landing funded for design in the 2024 provincial budget, the earliest that school can open will be September 2028. Chestermere schools will not be able to sustain the enrollment pressure until then, under the current structure, so altering student distribution and boundaries can provide a temporary relief to Chestermere schools.

In November 2023, a staff working group was formed to investigate the current situation in Chestermere and develop options for the better accommodation of student spaces until the new school opens. The group conducted a thorough review of Chestermere's situation in 2023/24, identifying possible solutions to address the student accommodation challenges including reviewing attendance areas, grade configurations, alternative schedules and modular classrooms.

The working group's findings and suggestions, combined with the announcement of design funding for a new school in Dawson's Landing and approval for additional modular classrooms, led to an option for consideration to help better distribute student spaces across Chestermere:

- East Lake School's English program expands from Kindergarten to Grade 6 to Kindergarten to Grade 9 beginning September 2025.
- The Christian and French Immersion programs for Kindergarten to Grade 6 remain at East Lake School while the Christian and French Immersion programs for Grades 7 to 9 would continue to be offered at Chestermere Lake Middle School only.
- Communities of Bridgeport commercial, Dawson's Landing, Chelsea, Waterford, Waterford Estates, and Paradise Meadows are redesignated from attending East Lake School to Rainbow Creek Elementary School.
- North Acreages area is redesignated from attending East Lake School to Prairie Waters Elementary School.
- Clearwater Park community is designated to attend Rainbow Creek.
- Bridgeport North is designated to attend Prairie Waters.

RVS administration presented the above option to the Board of Trustees for their consideration and direction on the next steps.

On October 3, 2024, the Board of Trustees passed the following motion:

STUDENT ACCOMMODATION CONSULTATION - CHESTERMERE #1404-2024 MOTION BY TRUSTEE SHALL BAZIUK:

The Board of Trustees approves the Chestermere Student Accommodation engagement plan, as presented, and directs administration to lead implementation beginning in October 2024.

Current Status

A comprehensive engagement process was developed and executed over the fall of 2024. The survey launched online on Oct. 3 and closed Nov. 26. Participants were asked to rank the issues most important to them in terms of the proposed option for balancing enrolment across Chestermere. See the December 12, 2024, summary report (attached) for a detailed description of the process and the findings from the engagement.

An in-person engagement session was also held at Chestermere Lake Middle School on Oct. 22 with trustees, RVS administration and executive in attendance to listen and help answer questions.

Key themes from the survey included:

- Respondents are generally in favour of the proposed changes.
- There continues to be considerable confusion about the process for building new schools. Many submissions referenced 'build a new school' as the solution.
- Greatest opposition is from parents/guardians with students in French Immersion (FI) who had
 concerns FI students would be segregated from their regular program friends by moving the
 program to a new school or concerns the program would experience a drop in registration as
 a result.
- Concerns about more changes in a community, that has already seen quite a bit of change in recent years this will be more disruption.
- Suggestions that some students be bused to the new high school in Langdon or to smaller rural schools to help with over-crowding in Chestermere's schools.
- Concerns that Rainbow Creek is already full. Concerned about not seeing a plan for additional washroom stalls to support the proposed increase in enrollment numbers.
- Respondents like, that this potential solution adds a middle school option, but many have
 questions about whether students currently in Grades 7 9 will be allowed to stay at CLMS.

Actions Taken to Date:

- Added 1 modular units at Chestermere Lake Middle School in 2024 school year.
- Received funding for 4 modular units at Rainbow Creek School in 2024 and the units will be ready for occupancy by August 2025.

Current students at CLMS remain there for rest of their Middle School.

We expect this project will get construction funding in the 2025 budget announcement by Government of Alberta. While not a given, the new school should open in fall 2028. While it would reduce change in the community, East Lake and CLMS would struggle to maintain their current configurations and attendance area until the fall of 2028.

Given continued growth projected for Chestermere, better balancing the growth and adding modulars where possible is administration's recommendation while we await construction of a new school in Chestermere.

Item: Summary of Feedback from Chestermere Student Accommodation Engagement

Date of Meeting: December 12, 2024

Background:

With a 262 per cent rise in population over the past two decades, RVS' schools in Chestermere are experiencing enrolment pressures that require new school builds as soon as possible. Until these much-needed schools are approved and built, the division must look at other means of balancing the existing student spaces to best serve Chestermere students overall.

An RVS staff working group conducted a thorough review of Chestermere's situation in 2023/24, identifying possible solutions to address the student accommodation challenges including reviewing attendance areas, grade configurations, alternative schedules and modular classrooms. A potential solution was developed and the Board approved the Chestermere Student Accommodation engagement plan on Oct. 3 to gather feedback and insights from the Chestermere community.

The goals of the engagement were:

- to collect valuable feedback from stakeholders to influence decisions about the plan and implementation;
- to ensure clear, consistent and transparent communication throughout the process; and
- to thoroughly communicate to maximize stakeholder awareness and participation.

A page was developed on <u>RVSEngage.com</u> to act as the main source of information for community members. This included tables of changes by school and by community, presentation slides and a survey. Approximately 2,200 visits to this site have been recorded.

The survey launched online on Oct. 3 and closed Nov. 26. Participants were asked to rank the issues most important to them in terms of the proposed option for balancing enrolment across Chestermere. Participants were also asked what they liked best and least about the option and to suggest any new ideas they might have for helping to mitigate crowding in Chestermere's schools. A total of 204 surveys were completed. Respondents did not need to register or provide any personal information to participate.

Key themes from the survey included:

- Respondents are generally in favour of the proposed changes.
- There continues to be considerable confusion about the process for building new schools. Many submissions referenced 'build a new school' as the solution.
- Greatest opposition is from parents/guardians with students in French Immersion (FI) who had concerns
 FI students would be segregated from their regular program friends by moving the program to a new
 school or concerns the program would experience a drop in registration as a result.
- Concerns about more changes in a community that has already seen quite a bit of change in recent years this will be more disruption.
- Suggestions that some students be bused to the new high school in Langdon or to smaller rural schools to help with over-crowding in Chestermere's schools.
- Concerns Rainbow Creek is already full.

RVS also held an engagement session at Chestermere Lake Middle School on Oct. 22 with trustees, RVS administration and executive in attendance to listen and help answer questions. The session was communicated via Chestermere school websites, the RVS website, a letter to Chestermere families, school newsletters and through local media.

At the event, Superintendent of Schools, Greg Luterbach and Director of Planning, Navi Sunkaranam presented a detailed slideshow to 67 attendees. Participants were then invited to take part in facilitated small group roundtable discussions based on the same questions as the survey. Data collected during these discussions was integrated into the online survey results.

Participants could complete the survey at the information session using the computers provided or click on a QR code, be taken to RVSEngage and complete the survey at their convenience.

Interested community members were also invited to prepare and present a delegation to the Board at its Dec. 12 meeting.

Current Status:

The RVSEngage Chestermere Student Accommodation engagement page continues to be the main source of information for community members.

Once the Board decision is made, it will be shared with Chestermere families, staff and other interested groups through a variety of channels.

Recommendation:

Background:

On January 9, 2025, RVS administration provided the Board Planning Committee an update on various aspects of Balancing Airdrie Student Spaces implementation efforts. The update included proposed communications from administration, updated projections, modular updates, staffing process, out of area process, resource allocation, and the grandfathering communications.

The updated projections identify a few challenging areas for 25/26 and beyond. RVS' Planning team updated enrolment projections based on Sept 30th numbers, current population trends, early data on age 0-4 population, and overall RVS projected enrolments for the upcoming school year. Given the importance of these numbers for staffing and planning, rather than these coming out in late February, these were shared with schools in December. The projections reflect the changes approved on April 25, 2024. As growth is not evenly dispersed across the community, projections evolve each time they are updated.

Includes two new K-9 Schools. Assumption is made that Southwindsong school will open in September 2027 and Bayview School in September 2028 and September 2028 and

Item: Improving our Students' Learning - Division Education Plan Update

Date of Meeting: January 23, 2025

Background:

The fall of 2023 began the implementation of Rocky View's new Division Education Plan. Coming on the heels of the previous 4YP that saw students and staff 'connect, achieve and navigate' before, during and after a global pandemic there is much to be excited about in our new plan and it's 'focus on the future'. The plan was developed after consultation with parents, students and staff across the division that used a blend of electronic means and in person sessions to collect feedback and help establish priorities for our work for the next four years.

Approved by the Board of Trustees in May 2023, the fall of 2023 saw the kick off the new plan and its goals that have our students achieve, build and create within a system that is future focused. By nurturing skills in numeracy, literacy, global citizenship, collaboration and problem solving, inclusivity within healthy and safe environments we are equipping our students for academic success and success in the dynamic challenges of the ever-evolving world.

Current Status:

Goal 1 – Advancing students' numeracy and literacy skills.

Outcomes:

- Students are numerate and literate.
- Students are actively engaged in meaningful and relevant learning.

In September of 2024 Alberta Government implemented mandatory literacy and numeracy screening for all grade 1 students. While the timing of the announcement and the implementation were not ideal, the data has been valuable. After reviewing the data, 10 schools have been determined to receive direct support from the learning specialists to implement a literacy and/or numeracy block in the K-3 classrooms. This work will begin in January and use government provided Learning Disruption Funding targeted at those 10 schools. Other schools may reach out for additional support and each request will be considered.



Students in grades 4-10 took part in the Elk Island Catholic Schools Math Assessment this fall for the first time. Results indicate that 60% of grade 4-10 students demonstrated math skills that do not require intervention, 14% would benefit from intervention and 26% need more intense intervention.



The spring of 2024 saw the implementation of the OurSCHOOL survey with grades 4-12 for the first time. The survey is a student perceptual survey that asks them questions related to how they feel about their school, their learning and skills, themselves and their future aspirations. Just over 15,000 students participated in the survey, and the schools are at the early stages of understanding the data.

Students in grades 4-6 reported interest and motivation in their learning to be below the Canadian average. 66% of RVS students said they are interested and motivated while the Canadian average is 78%. In grades 7-12, 27% of RVS students indicated that they are interested and motivated while the Canadian average for those grades is 33% with the low spot being at grade 9 and then slowly climbing back up through grades 10-12 both in RVS and nationally. This survey will be repeated again in the spring of 2025.

Goal 2 – Building future ready students. Outcomes:

- Students demonstrate strong abilities in critical thinking, communication, problem solving, collaboration, managing information, cultural and global citizenship, creativity and innovation, and personal growth and well-being (Alberta Education student competencies).
- Students graduate high school prepared to be successful for any path they choose.

The Career Learning Practice Guide is complete as of December 2024. This document provides guidance for all schools to advance career learning and planning for all students in grades 1 through 12. The Career Learning Practice Guide is built upon the framework of Explore, Engage, and Experience. The pragmatic approaches identified within the guide emphasize experiential learning, collective contributions of all staff, and partnerships with parents and community members who can share career related expertise.

Discussions between the Schools Department and administrators in all schools with middle and high school students took place between September and December. These discussions helped to inform the development of the practice guide as well as to provide an early preview of the content of the guide. All schools expressed enthusiasm for the work ahead in advancing career learning. Next steps to support the implementation of the practice guide include the establishment of an RVS career learning web presence, consultation with elementary school administrators, and strengthening community partnerships.

Our three English as an Additional Language (EAL) specialists are each assigned approximately 1/3 of our schools. One focuses completely at the high school level including the colony schools and the other two with the remainder of the schools. They provide targeted support to EAL coordinators, teachers, and administrators helping them address the language needs of EAL learners. They offer guidance on EAL Benchmarks, intake assessments, high school programming, clarifying timelines, and reporting processes. They also model intake assessments such as oral, writing, and reading assessments, empowering teachers to assess students independently. In addition, they collaborate with Rocky View Immigrant Services to provide extra support to students and families.

With EAL support being context-specific, the specialists tailor their guidance to meet the unique needs of each school and classroom. Teachers often seek support for their EAL students, either directly with the assigned specialist to their school or through their EAL coordinator. The specialists observe classrooms, collaborate with teachers on instructional strategies, and offer solutions for differentiating instruction. They model the use of scaffolding techniques such as visuals, language frames, and technology, ensuring alignment with curricular outcomes and key vocabulary. They also train teachers to use generative AI for creating and adapting materials to better support EAL learners.

Additionally, the specialists lead professional learning sessions and coach teachers on language acquisition, culturally responsive pedagogy, and integrating language development into content areas. They provide embedded, on-demand support to teachers, helping them plan using formative assessments, select key vocabulary, and apply scaffolding techniques. Through data analysis, classroom coaching, and collaboration, the specialists help refine instructional practices, advance student learning, and promote a shared understanding of language acquisition across grade levels and subjects. This approach fosters long-term innovation in literacy, numeracy, and curriculum engagement, preparing students for future success.

Goal 3 – Creating inclusive, engaging, healthy learning opportunities for all students. Outcomes:

- Students are happy, healthy, feel they belong and are safe, and experience success in learning environments that are inclusive of every learner and celebrate diversity.
- Students are self-aware, focused and demonstrate perseverance and resilience.

To support goal 3 and the identified outcomes in year two of the RVS school education plan, divisional learning supports has concentrated our efforts on ensuring equitable access and timely delivery to a diverse range of divisional supports and services, resulting in the submission and assignment of 364 referrals to date.

In addition, we are expanding and deepening our positive behavior interventions and supports (PBIS) implementation across all schools, with a particular emphasis on the implementation of a data collection system- Behavior Data Tracking module in Dossier and classroom implementation. This focus will continue support schools in utilizing data to predict, plan, and respond effectively to behaviors universally, targeted and intensively.

We collaborated with transportation, communications, and IT to enhance Positive Behavior Interventions and Supports (PBIS) on school buses, which includes the development, implementation, and training of bus drivers on the bus matrix and voice scale and supporting video bytes.

To strengthen our support for schools in managing behavior, we have developed and delivered a set of 5 professional learning modules that align with the rollout of the new Positive Behavior Support Plan process and document in Dossier. This includes the creation and implementation of a coordinated 5-point scale for behavior response; we have aligned the positive behaviour support planning document with the individualized program planning document to meet the diverse learning needs of students across the division. We also designed and implemented an intensive coaching and debriefing model to assist school teams with the effective implementation of positive behavior support plans. As part of our support for schools, we finalized, had approved and have made active the Rocky View Schools Responding to Behaviour Guidelines and Fair Notice, that is active on all school websites.

Future Direction:

Plans for the second half of the year:

- Final development of the RVS Writing Assessment will see the complete set of assessment rubrics for all grades this spring for implementation in the fall of 2025.
- Targeted supports for numeracy and literacy in specific schools while supporting the growth in other schools.
- Implementation of the parent version of the OurSCHOOL survey in the spring of 2025.
- Further expansion of behavior data tracking related to PBIS.
